2. The Data or any product derived from the Data, either digital or hardcopy, must not be sold, given away, traded, negotiated or leased.
3. The User may only use the data for the purpose stated above.
4. The User may utilize the data in presentations, publications, studies and reports, provided that the data source is explicitly referred to, or in case of demonstrations, objects or items on display, a clearly visible label is attached acknowledging that these data have been provided by the "Water Development Department of the Republic of Cyprus".
5. In cases of substantial contribution of WDD Officers to the preparation of the product and the provision of data, an offer should be made to the WDD Officers for their inclusion as authors of the resulting presentations / publications / texts / studies.
6. Prior to using / publishing / presenting data provided by the Water Development Department, the User must send any texts / presentations containing, or resulting from, such data to the WDD for corrections and comments.
7. The User must provide the WDD, in paper or digital form, with copies of the reports and any publications produced by using the provided data. Copies of derived data must be given to the Water Development Department in digital form.
8. The Data are put at the disposal of the User until the end of ....., at which time the Data have to be deleted from all computers of the User and the CDs or floppy discs have to be returned to the Provider.
9. This Agreement can be modified or terminated by mutual consent of User and Provider. This must be done in writing.
10. Legal measures will be taken in the case that this contract is breached. This contract is subject to the Law of the Republic of Cyprus.
